In 2011 we created our Memorial Garden. It's in a peaceful location adjacent to the track at Northiam Station and provides a special way for loved ones to be remembered.



England's finest rural light railway

An important part of railway history

The Kent & East Sussex Railway is widely regarded as England's finest rural light railway.

Built by Colonel H F Stephens, the line originally ran between Headcorn and Robertsbridge.

Its closure in 1961 coincided with the formation of a fledgling preservation society that has grown into the heritage railway we are proud of today.

The current line runs from the Wealden market town of Tenterden through the Rother Valley to Bodiam brushing

Legacies

Leave a legacy - the gift of a lifetime

We realise that Will writing can be difficult and sensitive. Determining what gift is right for you is just as important as making the gift.

There are many options from which you can choose. A number of these are listed within this leaflet. The correct gift for you balances what you wish to accomplish for yourself, your family, and your charitable interests.

However, whilst completing this task we would be pleased if you could kindly consider including K&ESR among your wishes. The decision to leave a gift to charity is a big one. Here we outline three methods of gifting a legacy.

A Residuary Legacy: this is a percentage or all of what remains after your expenses and other legacies have been paid. A residuary legacy is the best way to benefit the Railway because it's unlikely to be affected by inflation. For example, if your estate's residue is worth £10,000, a 5% residuary gift to the Railway will be £500. By using this method, you can be sure that your gift is always within your means, whatever your financial circumstances in later life.

A Pecuniary Legacy: this is a gift of a specific sum of money. For example, £1000 will fund the repainting of a signalbox; £5k will provide a forklift truck for workshop use. For £10k we will re-upholster a complete carriage and £40k will enable us to provide and equip a coach as a state-of-the-art education facility.

A gift of £75k will fund the restoration of a coach and £100k will fund a 10 year overhaul of a locomotive.

A Specific Legacy: this is an item of value, such as a house or shares.

Any gift, irrespective of size is vitally important to the K&ESR. It will be wisely used to ensure the K&ESR's long-term future. This is our commitment to you.

Inheritance Tax

As the Kent & East Sussex Railway is a registered charity, legacy gifts will be free of inheritance tax.

Briefly, inheritance tax is the tax paid on your 'estate'. This is all you own at the time of your death, less what you owe. Assets include property, possessions, money and investments. Tax is payable at the rate(s) set by the

past the villages of Rolvenden, Wittersham and Northiam.

We are the current custodians of the Railway, ensuring that it is maintained and improved, so that future generations can both enjoy it and ensure that it remains into perpetuity.

An extremely important part of our income sources are generated from donations and legacies. These are vital to our future financial well being and allow us to fund improvements to the Railway that would otherwise be difficult to achieve.

Donations

A donation in memory

Making a donation to the Kent & East Sussex Railway in memory of someone who was special to you is a unique way to ensure that their memory lives on, whilst paying tribute to the interests that were important to them.

At your request, the K&ESR can set-up a 'Living Memory Fund' in your loved one's name. Friends and family members may then make contributions to this fund. A great comfort at a time of loss, a Living Memory Fund celebrates a life, whilst helping to ensure the future of the Railway.

Regular donation by direct debit

Donating a regular monthly sum is a manageable method of giving. Whatever sum you are able to donate, please be assured every single penny enables us to care for the railway today and into the future. Government on the amount above the inheritance tax threshold. Not everyone pays inheritance tax. It only applies if the taxable value of your estate when you die is above a certain amount.
